POWER OF ATTORNEY

I, John R. Hawkins, hereby authorize and designate each of Richard G. Erstad, Steven C. Kenney, W. Morgan Burns, Erik J. Romslo and Joshua Colburn, signing singly, as my true and lawful attorney-in-fact to:
